Dear LEA CAASPP Coordinator:

If your local educational agency (LEA) is using the NeoSpeech Julie Voice Pack for the English text-to-speech resource for California Assessment of Student Performance and Progress (CAASPP) testing, please note that **the license agreement between NeoSpeech and the CAASPP System for use of the Julie Voice Pack expires on May 3, 2017. After this date, devices will default to the locally installed voice pack unless the license is updated.**

To continue using the Julie Voice Pack, LEAs must update the license agreement locally on their Windows-based devices using one of the following options:

Instructions to Update the NeoSpeech Licensing Agreement Text File (available now)

1. Log on to the Test Operations Management System (TOMS).
2. Select the [Help] icon from the navigation banner at the top of the application window.
3. Select the [Voice Pack Resource] tab.
4. Review the Voice Pack Installation Instructions (select the [**Download**] button next to this option to begin).
5. Download the Verification (license) file (select the [**Download**] button next to this option to begin).
6. Copy and paste the text in this file into Windows Notepad.
7. Save as a text file in the same location on your device as the original licensing agreement text file so that the file overwrites the original file:

Version 32-bit Windows

C:\Program Files\VW\VT\Julie\M16-SAPI5\data-common\verify\

Version 64-bit Windows

C:\Program Files (x86)\VW\VT\Julie\M16-SAPI5\data-common\verify\

Instructions to Reinstall the Full Julie Voice Pack (available May 1)

1. Log on to TOMS.
2. Select the [Help] icon from the navigation banner at the top of the application window.
3. Select the [Voice Pack Resource] tab.
4. Review the Voice Pack Installation Instructions (select the [**Download**] button next to this option to begin).
5. Download and install the Installation file (select the [**Download**] button next to this option to begin).
